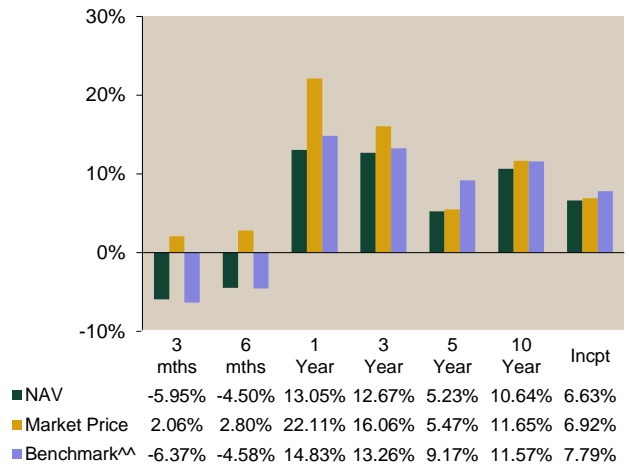

PERFORMANCE as of 01/31/2022



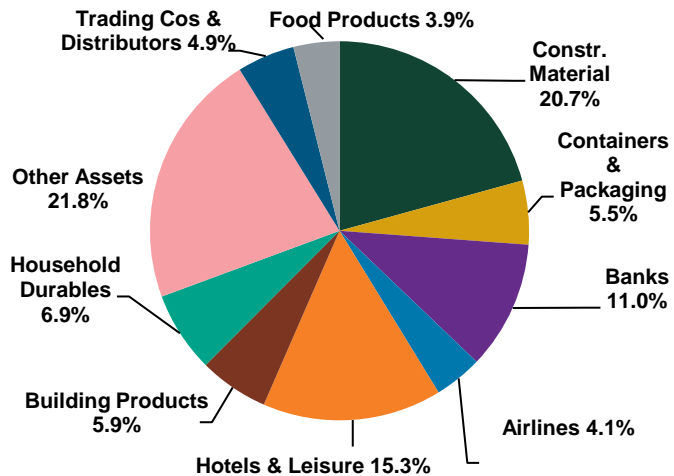
