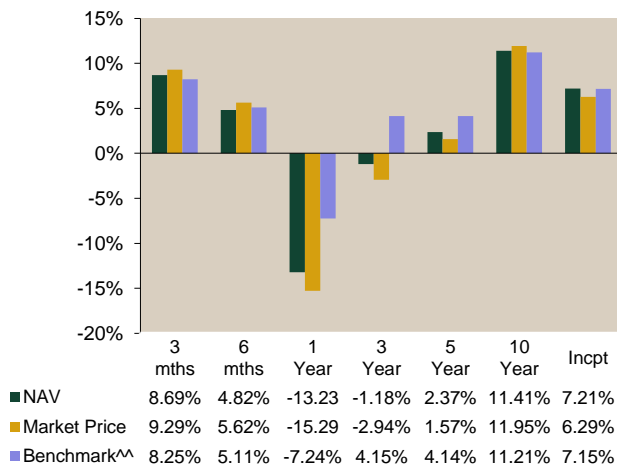

PERFORMANCE as of 4/30/2019



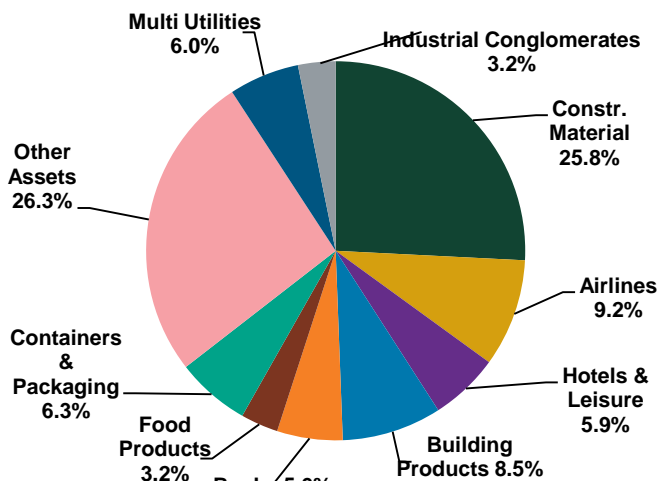
